Terms and Conditions

1. I accept that the Hirer has hired the above mentioned vehicle to me and I am bound by the terms and conditions of this agreement
2. I accept that I will be the sole driver of the Vehicle during the period of hire and it will only be used for purposes covered by my insurance.
3. I accept that I am responsible for insuring the vehicle to its full value with comprehensive insurance prior to and while the vehicle is on hire and that my insurance details are as stated as above.
4. I accept that irrespective of liability I am expected to make full payment for all loss or damage however caused during the period of hire as claimed from the insurance company or otherwise and I will indemnify the Hirer against my claims or action consequential or otherwise arising from the Hire. My statutory rights are not affected.
5. I accept that the hirer shall not be liable for any loss or damage to property carried in or on the vehicle during the hire and I am responsible for the safe care and use of the vehicle during the hire period
6. I accept the vehicle will be returned by 5 PM on the date of return stipulated above unless otherwise agreed in writing with the hirer.
7. I accept liability for any offences arising from my use of the vehicle under the Road Traffic Act, Road Traffic Offenders Act and Road Traffic Regulations, Subordinate Legislation, congestion charges parking or any other penalties while hiring the said car and indemnify the hirer accordingly.
8. I confirm that I shall contact the hirer immediately by telephone in the event of an accident or breakdown
9. I confirm that I am not authorised to arrange for recovery or repair without the consent of the hirer.
10. I understand that I am responsible for the fuel and other consumables and for checking and maintaining levels and tyre pressures during the period of the hire. I undertake to inform the hirer in the event of any mechanical issues arising.
11. I confirm that I hold a valid driving license for the hire vehicle valid for the duration of the hire.
12. I confirm that I have been made aware of the operation of the hire vehicle controls and its performance
